Product types included in this contract are Two-Post Lifts, Four-Post Lifts, Mobile Column Lifts, Parallelogram Lifts, Scissor Lifts, and In-Ground Lifts.

F.O.B. Point: The Contractor pays freight costs to the port of Seattle and this cost must be included in the Contract Price offered to the Participating Entity. The Purchasing Entity pays actual freight costs from such port to the final destination. The Contractor must include a freight cost invoice from the carrier for this cost to be submitted. This cost must be listed on the contractor's invoice as a separate line item. Contractor owns goods in transit to the final destination and is responsible for filing claims (if any).

Mohawk Lifts, Prompt Payment Discount: For deliveries in the Anchorage, Fairbanks, and Juneau areas, Mohawk Lifts offers an additional 5% (5 percent) discount, for all invoices paid within 10 business days from the date of receipt of the commodities or services and/or a correct invoice, whichever is later.

The Anchorage, Fairbanks, and Juneau areas are defined as within respective city/borough limits and all surrounding communities that are accessible by roadway and within a 50-mile radius of city/borough limits. For deliveries outside these areas, the discount shall apply for invoices paid within 10 days of the date of shipment from Seattle, WA.

The discount shall be taken on the full invoice amount. Payment being made is considered either the date a printed warrant is issued or the date an electronic funds transfer (EFT) is initiated.

Vehicle Services Group, Prompt Payment Discount: For all deliveries, VSG offers a .5% (½ percent) discount, for all invoices paid within 15 business days from the date the invoice is submitted to the State by the Contractor.

The discount shall be taken on the full invoice amount. Payment being made is considered either the date a printed warrant is issued or the date an electronic funds transfer (EFT) is initiated.
