Order Form Requirements. All Orders pursuant to this Master Agreement, at a minimum, must include:

- 1. The services or supplies being delivered;
- 2. A shipping address and other delivery requirements, if any;
- 3. A billing address;
- 4. Purchasing Entity contact information;
- 5. Pricing consistent with this Master Agreement and applicable Participating Addendum and as may be adjusted by agreement of the Purchasing Entity and Contractor;
- 6. A not-to-exceed total for the products or services being ordered; and
- 7. The Master Agreement number or the applicable Participating Addendum number, provided the Participating Addendum references the Master Agreement number.

**Delivery:** All equipment shall be delivered FOB final destination. All transportation and handling charges will be paid by the ordering entity. Charges paid by the ordering entity are to be annotated on the quote/invoice as a separate line item. Delivery on parts is to be made within 30 calendar days and delivery of equipment shall be made within 120 calendar days after receipt of order unless other arrangements are made between the Purchasing Entity and the Contractor.

**Warranty and Buy Back:** Contractor is required to provide any buy-back, trade-in, or exchange policy concerning repair parts sold to Purchasing Entities. Contractor shall correct ordering errors without further cost to the ordering entity. A copy of the Warranty shall be included for replacement parts purchased.
