Alaska is an active member of the National Association of Procurement Officials (NASPO). Through the NASPO contracting arm, NASPO ValuePoint (NVP), cooperative contracts are solicited and awarded that leverage the buying power of all 50 states and several U.S. territories to offer exceptional pricing for participating states and their political subdivisions. To use a NVP contract, the State must sign a Participating Addendum (PA) to the awarded Master Agreement (MA). Below are the current PAs that have been established for this portfolio.
