Incontinence supplies are available through this contract, along with other medical supplies.

Delivery: Delivery of products under this Agreement shall be FOB Destination. Vendor will not add any fuel, shipping, or handling surcharges to the purchase under this Agreement, except for:

- Emergency orders
- Rush orders
- Orders for product(s) not purchased by any Member in the preceding 12 months and therefore not adequately stocked by vendor
- Products dropped shipped from vendor's contracted supplier

All deliveries will require a minimum order of \$250 for free delivery; otherwise vendor will display delivery charge before purchase is finalized.

For emergency orders and deliveries: Vendor may pass through all shipping costs to the Member, however it will not assess any "handling" fees or assessments.

Orders must be processed and shipped the same day. If the product is not delivered to the Member within 24 hours, the Member will not have to reimburse the vendor for shipping; Holidays do not exempt this time requirement. If the delay is due to the carrier, the vendor will seek remedies from the carrier, not the Member.

Ordering: Vendor's daily order cut off time will be 12:00pm (noon) local time to the Member.

In the event the product(s) covered by this Agreement are not available at the time of order placement, product substitution will only be permitted upon the written consent of the Member.

Bulk Orders: A bulk order is an order that will exceed \$100,000 in dollar value. It is expected that the vendor will provide a "volume" discount on Bulk Orders; however, the vendor may negotiate with the Member a reasonable shipping fee as part of the proposal.
