### MANDATORY FOR EXECUTIVE BRANCH STATE AGENCIES

### AVAILABLE TO POLITICAL SUBDIVISIONS

The Office of Procurement and Property Management (OPPM) has established the following contracts for the bulk purchase and delivery of all grades of **Heating Oil** in various locations throughout the state. To utilize the contracts, contact the vendor listed for the location you wish to purchase fuel for, let them know that you are using a state contract, provide the contract number and exact location of fuel delivery ( Bldg. #, Tank #, address). Contact information for each vendor is provided below. **The term “heating oil” can have several meanings, however under this contract it is intended to be used to heat buildings and other structures, using Heating Fuel/Diesel #1 and Heating Fuel/Diesel #2.**

Standard Delivery pricing is based on the Oil Price Information Services (OPIS) Daily gross rack average in effect on the day of delivery for the type and grade of fuel delivered, plus or minus the Mgt Fee listed below.

The OPIS Daily gross rack average price information is published twice daily in the OPIS Newsletter. For deliveries on Saturday-Monday, the price in effect is the OPIS published the previous Friday.

Remote delivery pricing is based on the contractor's current Retail Price (less taxes), minus the Discount, and plus or minus the Delivery Surcharge (if applicable), listed in the table below. This equals the **Total Cost per Gallon** of fuel.
