Table A identifies the locations where the purchase and delivery of **Ultra-Low Sulfur Diesel** is **mandatory** for executive-branch state agencies. **NOTE:** The DNR/DOF is considered exempt from mandatory use of this contract (see contract).

Pricing for the locations listed in Table A are based on **Standard Delivery** pricing. Standard Delivery pricing is based on the Oil Price Information Services (OPIS) Daily gross rack average in effect on the day of delivery for the type and grade of fuel delivered, plus or minus the Mgt Fee listed below.

The OPIS Daily gross rack average price information is published twice daily in the OPIS Newsletter. For deliveries on Saturday-Monday, the price in effect is the OPIS published the previous Friday.
