This Statewide contract is for Police Radar/Lidar Speed Enforcement & Speed Advisory Systems, Parts & Accessories.

State and local law enforcement agencies rely on National Highway Traffic Safety Administration (NHTSA) approved police radar/lidar speed measuring devices for quality, accuracy, and traffic court acceptance. They use the Conforming Product List (CPL), established and maintained by the NHTSA, as the standard for procuring their devices.

The CPL is a list of manufacturers and their approved products. To meet the needs of state and local law enforcement agencies, this RFP only considered the manufacturers and their products listed on the CPL.
