The NASPO ValuePoint (formerly WSCA-NASPO) cooperative purchasing organization has established contracts for a wide range of facilities maintenance supplies, lighting products, industrial supplies and tools. These contracts are available to state agencies and their political subdivisions. In order to use the contracts, the state must sign a Participating Addendum (PA).

Discount Percentages off List Price

Note: Grainger's discounts are based off their Contract Reference Prices (CRP), which is market based and lower than Grainger's historical List Price. Because CRP is lower than Grainger's prior List Price, contract category discounts are also lower.

CRP can be found on the Grainger website when customers log in to their Grainger account. When comparing vendor pricing, is important to compare actual prices and not just discount percentages.
